Revenue Total Revenue - \$106,706 in 2024, up from \$27,190 in 2023 (+292%) Casino Proceeds: \$83,289 (primary revenue source, not present in 2023). Fun Lunch (Net): \$18,805 (a steady performer; up from \$17,265). Spirit Wear Orders: \$2,042 (a new addition to revenue streams). Bacon Fundraiser: \$2,025 (down significantly from \$7,295 in 2023 – profitability challenges, high management efforts to track/issue). Expenses \$69,733 in 2024, up from \$40,885 in 2023 (+70%) Gaga Ball Pit: \$9,536 (largest individual expense). Glass Residency: \$8,558 (substantial investment in student enrichment). Wool Residency: \$7,183 (listed in 2023). Staff & Volunteer Appreciation: \$6,306 (up from \$5,133 in 2023). Electronic Equipment/Software: \$4,532 (new expense).
